

Irrigated farms by tenure of the operator.— Data for irrigated farms were tabulated for 20 specified States for the Census of 1940 and for 19 specified States for 1930. Farms, farm acreage, and specified farm values are presented for irrigated farms by tenure of the operator, as a summary in table 17 and by States in table 33. Data for cash rent paid by cash tenants and by part owners renting on a cash basis are

presented for irrigated farms in tables 18, 34, and 35. The classification as to irrigation for the Census of 1940 was based on irrigated cropland harvested and irrigated pasture in 1939, and for the Census of 1930 on irrigated crops harvested in 1929. Some of the data for irrigated farms presented in this chapter only as State totals are available by counties in the irrigation census reports.
